In addition to late fees, penalties may include, but are not limited to suspension of Club privileges and/or expulsion from membership. I/We agree to pay all reasonable attorneys' fees, investigator fees, and costs in the event this account is turned over for collection.

**General Conditions for Gate Governors Club Memberships (if applicable)**

1. Gate Governors Club membership is a membership in two or more of Gate-owned clubs. A member is entitled to use only the clubs for which the initiation and membership dues are paid.
2. Home Club Rule: The designated Home Club is the club (or clubs) originally joined and where initiation fees have been paid in full. Members may add a club to their original membership at any time by paying an "add on" fee. If at some future time the member decides to drop the Home Club, he/she will be able to retain the add-on club by paying the current initiation fee for that club less the amount paid at the time the member joined the Governors Club

## GENERAL CONDITIONS OF MEMBERSHIP

1. The Club shall have the absolute right to designate persons who are eligible for membership and who shall have the right to use any or all the facilities of the Club, upon such terms and conditions as determined from time to time by the Club. Eligibility for membership shall not be based on grounds of sex, race, color or national origin.
2. Club bills are due and payable upon receipt. Bills past due in excess of 30 days will be considered cause for suspension and a service charge of 1- ½% per month (18% annual percentage rate) will be applied on past due amounts. A \$150.00 reinstatement fee shall be required if a membership is suspended for failure to pay bills past due. In addition to suspension of membership, failure to pay dues and/or club accounts will result in expulsion if suspension of the membership occurs two times during the year. If it should become necessary for the Club to institute proceedings to collect any delinquent accounts, the Member shall be liable for all fees and costs including any reasonable attorney's fees associated therewith.
3. Applicant understands that membership may be suspended or cancelled (without refund) if Club rules or policies are violated by a member and/or their guest.
4. Membership cards are not transferable and may be used only by the member and eligible dependents.
5. Initiation fees and dues are non-refundable, non-transferable, and subject to sales tax.
6. The Membership Department must be notified immediately of any change of status to membership. This includes adding/removing a spouse as a result of marriage or divorce, additional dependents, death of a member, employment changes, residence or phone numbers.
7. All membership categories extend privileges to the member, spouse and dependents under the age of 26.
8. The club will not be responsible for loss or damage to property of members or their guests on the Club's property.
9. It is understood that a member may resign from the Club by giving thirty (30) days advance written notice to the Club and by paying any outstanding dues and charges incurred prior to termination. It is further agreed, however, that a member may not offset dues or charges against the initiation fee.
10. Pets are not permitted on the Club's property at any time.
11. Each member will be provided with a "Member Handbook" (updated annually) which contains additional information regarding facilities, dues, fees, guests, dress codes, etc. Members are expected to comply with policies therein as well as those listed above.
12. While every effort will be made to inform Members in advance of dues, fees and Club policies, we reserve the right to make such changes without prior notification whenever deemed necessary.
